




Test Procedure	<p>Step 1: Use a fast power sensor suitable for 2,4 GHz and capable of 1 MS/s. Use the following settings:</p> <ul style="list-style-type: none"> - Sample speed 1 MS/s or faster. - The samples must represent the power of the signal. - Measurement duration: For non-adaptive equipment: equal to the observation period defined in clauses 4.3.1.2.1 or 4.3.2.3.1. For adaptive equipment, the measurement duration shall be long enough to ensure a minimum number of bursts (at least 10) are captured. <p>Note 1: For adaptive equipment, to increase the measurement accuracy, a higher number of bursts may be used.</p> <p>Step 2: For conducted measurements on devices with one transmit chain: -Connect the power sensor to the transmit port, sample the transmit signal and store the raw data. Use these stored samples in all following steps.
